

## UPC COURSES SUMMARY - INTERNATIONAL STUDENTS

### LEADERSHIP AND MANAGEMENT

The program comprises 3 stages: (a) Studying Diploma/Advanced Diploma at UPC College, (b) Bachelor at UPC’s partners (Higher education institutes or universities) and (c) 2-year work experience.

- Purpose: Training you to become a manager and leader in any business enterprises.
- Entry level: Academic - Completed Year 12 or equivalent; English – IELTS =5.5 or higher
- Study and work experience period: Up to 6 years including:
  - Certificate IV of Business (6 months).
  - Bachelor of Business or Management or Human Resources, etc. at one of UPC’s higher education partners (2 years).
  - Diploma of Leadership & Management (9 months).
  - Postgraduate work experience (2 years).
  - Advanced Diploma of Leadership & Management (9 months).

#### **Certificate IV in Business BSB40215** (CRICOS 087792K) – Student visa sub-class 500 (6 months at UPC College)

- Purpose: Gaining general skills in business and management.
- Intake: Every fortnight during the term (Learning materials: \$150)

#### **Diploma of Leadership & Management BSB51915** (CRICOS 087793J) – Student visa sub-class 500 (9 months at UPC)

- Purpose: Training you to become a low-level manager
- Intake: Every fortnight during the first 6 weeks of each term (Learning materials: \$200)

#### **Advanced Diploma of Leadership & Management BSB61015** (CRICOS 087794G) – Student visa sub-class 500 (9 months at UPC)

- Purpose: Training you to become a middle-level manager
- Intake: Every fortnight during the first 6 weeks of each term (Learning materials: \$200)

#### **Bachelor of Business, Management, Human Resources, etc.** at UPC’s higher education partners – Visa sub-class 500

- Purpose: Training you to become a manager in a wide range of business enterprises.
- Study period: Maximum 2 years - Intake: Two or three intakes per year.
- Tuition fees and learning materials: Variable.

#### **Post graduate Work Experience** – Visa sub-class 485

- Purpose: Gaining experience to become an experience manager in specific field of study.
- Work experience period: 24 months.
- Employment: Fully-paid full-time employment.
